Deposit and Full payment terms:

- A '**non-refundable**' deposit of **USD 1000** of the Tour fee as booking amount to reserve your spot
- The remaining balance is due in **full 90 days before the start of the tour**. If you would like to pay the remaining balance in installments, please let us know.
- All figures in USD per person
- Failure to make payments within this timeline could result in tour cancellation
- A deposit is your commitment to joining the workshop. These deposits don't typically sit in an account, they are used to cover initial expenses for the workshop like hotel reservations, park permits/fees and guided tour deposits. Due to these expenses, deposits are non-refundable and tour payment made is subject to a cancellation fee.

Cancellation terms

If cancelled by you:

- **More than 60 days before the start of the tour:** Refund of workshop payment (not including deposit), less \$100 convenience fee.
- **60 - 45 days before the start of the tour:** Refund of 50% of workshop payment (not including deposit), less \$199 convenience fee.
- **Less than 45 days before the start of the tour:** No refunds will be given, and all payments will be forfeited. Full payment is required no later than 45 days prior to departure. If full payment is not received by this date you will be notified by email. If you do not respond within 3 business days, your spot will be forfeited and offered to participants on the waiting list.
Please note: The date of written (email) communication of intent to cancel is the date considered for calculation of the cancellation fees.

If cancelled by us:

Other than during the coronavirus pandemic, Tropical Photo tours has never cancelled a tour. We are committed to provide a seamless experience to all our guests and understand that unceremonious cancellations may cause unnecessary expenses and cancellation fees. Any event that causes a cancellation beyond our control will result in the transfer of all payments to a future event.

CANCELLED WORKSHOPS: If we are forced to cancel a workshop for any reason, your entire payment will be transferred to another comparable workshop within one calendar year.

Personal emergencies: If you have a personal emergency, please contact us immediately; we are willing to work with you to reschedule on a case-by-case basis.

1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by Tropical Photo Tours, or the employees, representatives or agents of Tropical Photo Tours.

2. ASSUMPTION OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above described activity and I assume full responsibility for personal injury to myself and (if applicable) my family members, and further release and discharge Tropical Photo Tours for injury, loss or damage arising out of my or my family's use of or presence upon the facilities of Tropical Photo Tours, whether caused by the fault of myself, my family, Tropical Photo Tours or other third parties.

3. INDEMNIFICATION. I agree to indemnify and defend Tropical Photo Tours against all claims, causes of action, damages, judgments, costs or expenses, including attorney fees and other litigation costs, which may in any way arise from my or my family's use of or presence upon the facilities of Tropical Photo Tours.

based upon their status as the drafter of a specific term, language, or provision giving rise to such ambiguity.

8. ENFORCEABILITY. The invalidity or unenforceability of any provision of this

Agreement, whether standing alone or as applied to a particular occurrence or circumstance, shall not affect the validity or enforceability of any other provision of this Agreement or of any other applications of such provision, as the case may be, and such invalid or unenforceable provision shall be deemed not to be a part of this Agreement.

Insurance/Cancellation/Delay:

Please note that the above listed terms are only applicable for Tropical Photo Tours tour fee only and does not cover your travel/personal insurance and costs. There shall be NO REFUND for weather delay or cancellation because of weather before arrival or during the scheduled workshop. Tropical Photo Tours is not responsible for any additional costs that may be incurred by weather delays or cancellations due to weather, flight delays, or otherwise.

We reserve the right to cancel the tour and participants will be informed about this in advance. The payment made would be treated based on the cancellation terms above.

Changes to Itinerary:

Changes may be made to the stated itinerary if in our professional opinion it will benefit the workshop and its participants by providing better photographic opportunities. A change in the order that locations are visited is not deemed to be a major change. Should a major change of itinerary or schedule be forced upon us while the tour is in progress (for example due to strikes,



weather delay or breakdown) any additional costs are the responsibility of the participants. Once again, we insist that travel insurance is essential.

Lodging:

We at Tropical Photo Tours try to book the lodges based on the Photographic opportunities, they may not always be of the same comfort or facility level as of a luxury lodge. Most Rainforest lodges are nestled in forests with comfortable, clean accommodation and local food options. On very rare occasions the accommodation that has been reserved for the tour may not be available and under such circumstances we shall arrange an alternative accommodation of similar standard.

Travel:

All participants are responsible for, and must be in possession of, a full passport, valid for at least six months beyond the end of the tour. Participants must also obtain any necessary visas by checking with the respective Consulates and vaccination certificates before the start of the workshop.
